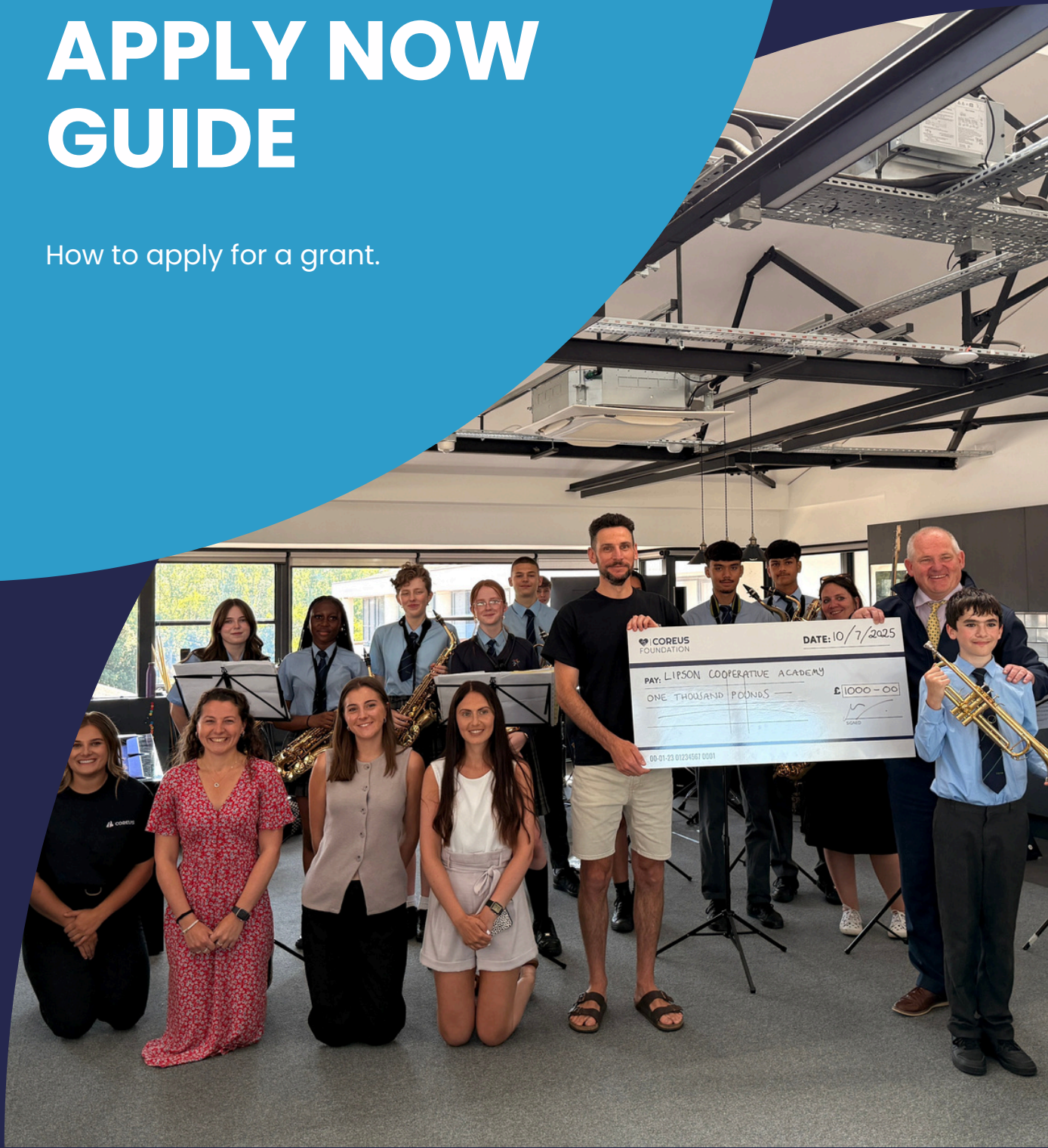

How to apply for a grant.



# GUIDE FOR FUNDING APPLICANTS 2025

*The Coreus Foundation (TCF) has been set up with the goal of positively impacting the communities in which we live and work. Each year, Coreus Group (Coreus) hosts various fundraising events for TCF and has committed to donating 1% of net profits to TCF by 2030. Funding is then made available to our local communities by way of grants, as described below.*

## How much is available?

The amount available for organisations to bid for varies from year to year, depending on the amount raised for TCF. This year, the total amount to be divided across multiple organisations or projects is up to £10,000.

## What can you apply for?

TCF aims to support organisational objectives and charitable projects that meet TCF's charitable objectives and broadly align with its 3 core pillars:

- **Knowledge** Promoting the education and training of all people, in particular those who would otherwise not have access due to poverty or social and economic circumstances
- **Health** Consistent with Coreus' 'people first' agenda, supporting the physical and mental health and wellbeing of all people
- **Conservation** Promoting the conservation, protection and improvement of the environment in the fight against climate change

Proposed projects must be able to explain how they support one or more of these three pillars. In addition, applicants must be able to demonstrate that their proposed work is addressing a clear need within their organisation or the broader local community.

Funding provided by TCF can finance a project/service or charitable objective, to expand or continue existing services, to purchase an asset, or to support the day-to-day running of their organisation.

A grant may cover physical resources like equipment or revenue costs such as educational materials, or help towards staffing or insurance, where these are directly associated with the project.

## **How much can we award?**

The allocation of available funds will be determined by the number and quality of the applications based on the assessment criteria below. The amount of the award is not set in advance; however, it is likely this year they will each be between £500 and £2,000 to enable several projects to receive substantial assistance.

While co-funding/match-funding is not a prerequisite for an award, we would like to hear whether you have, or expect to receive, additional funding from other sources towards your project.

## **What areas can benefit from the award?**

To be eligible, the organisation must be in the following areas where Coreus operates: Exeter, Bristol, Birmingham, London, Truro and surrounding areas.

## Who can apply?

Applications are invited from the following types of organisations:

- Towns and Parish Councils
- Registered charities, CICs, community benefit societies and other social enterprises
- Schools and other educational organisations
- Local constituted 'not-for-profit' community groups (including clubs and societies)
- Local community leaders/champions (individuals who are engaged in community service through recently formed or less formalised organisations)
- Religious organisations are eligible if the project benefits the wider community and doesn't include religious content or promote religion

In your application, you may be asked to share documents which demonstrate the viability of your existing organisation or initiatives. This could be done in a few different ways, such as providing any of the following: a copy of your organisation's constitution, rules or meeting minutes, the names of committee members and aims of your group, a business plan, evidence of previous community work, or an explanation for why none of these are available at the time of application.

If your application is successful, you will need to supply details of your organisation's bank account and a recent bank statement, or, if you do not have a bank account, details of the bank account from the organisation that has agreed to receive the award for you. If this is not possible, you must agree to open a bank account before the receipt of the funds if successful. Details of the costs of the project will be required, and any provider you plan to use. For any single cost with a value higher than £500, we require two written quotes, the name of your preferred provider, and the reason for your choice. Applicants can only apply for one grant per year.

## Who don't we fund?

- Grant or loan schemes run by third parties
- Commercial or 'for-profit' organisations
- Statutory organisations (except Town and Parish Councils)
- Retrospective costs
- Grants in areas where Coreus is not active
- Organisations which adopt a partisan political stance or which promote activities which are party political.
- Organisation that include religious content or promotes religion.

## What is the application process?

Applicants must complete and submit a funding application form within an open funding application window. We are open to receiving funding applications within one annual window. We invite applications within the period of 1st September – 31st October 2025.

Once we have received your completed application, we will check its eligibility, and if we need any additional information, we will contact you.

## How do we allocate and pay awards?

Following the closure of each application window, our Board of Trustees will meet to consider the funding applications received, discuss donation logistics, and decide on successful applicants. Decisions regarding any funding awards are at the discretion of TCF Trustees, in accordance with the grant-making policy adopted by TCF Trustees from time to time. We have specific criteria against which all applications are judged. These criteria are outlined in the table on the following page.

The number of successful applicants will vary each year depending on both the funding requirements of those applying and the budget of TCF.

Chosen applicants will be notified shortly afterwards. Any funding awards shall be subject to the applicant agreeing in writing to TCF's grant award conditions as issued from time to time and may be subject to additional specific conditions which TCF may notify to the applicant. TCF Trustees' decision as to whether or not to award a grant is final.

We aim to announce the funding allocation by mid-December 2025 and mid-August 2025 for the bidding window.

## Key dates

- Bidding window: 1st September 2025 – 31<sup>st</sup> October 2025
- Grant allocations announced: Early-mid December 2025
- Next bidding window dates announced: 1st June – 31st July 2026
